

UoNA Student Code of Conduct

Students are expected to behave and treat others on campus as professional scholars. Students attend the University from all parts of the world and from many varied backgrounds. This diversity provides a rich environment for the free exploration and expression of ideas, and students are expected to participate fully and to uphold the right of others to do the same.

Students are expected to abide by all public laws and generally accepted professional standards, to comply with all regulations and policies of the University, and to conduct themselves professionally when interacting with fellow students, faculty, and staff. The University reserves the right to place a student on disciplinary warning, probation, suspension, or dismissal, who engages in unsatisfactory conduct such as dishonesty; failure to adhere to rules and regulations; destruction or theft of property; participation in activity that impinges on the rights of others; or possession or consumption of alcoholic beverages or illegal drugs at any time on these premises.

Academic Integrity.

Includes plagiarism & all elements as defined in the policy. Faculty are required to submit a record of all violations and penalties to the VP of Academic Affairs.

Collegial Responsibility.

Includes (a) Timely submission of assignments and (b) Participation in scheduled class sessions or activities

Consequences

The student will receive a grade of "F" for the assignment. The student will be required to attend a class session with the instructor. 2nd violation of policy - The instructor will choose one of the student's assignments to be used as administrative evidence of a consultation with the VP of Academic Affairs. The student will be required to attend a class session with the instructor. 3rd violation of policy - The instructor will choose one of the student's assignments to be used as administrative evidence of a consultation with the VP of Academic Affairs. Appeals Process.

Students may submit an appeal if they have extenuating circumstances and they request the appeal within two weeks of the occurrence.
